Pat Regan was not able to attend the meeting due to personal reasons. Mike Dreznes presented the Financial Report as of August 13, 2024, on Pat's behalf.

Mike showed two attachments. The first attachment showed the YTD Activity. Our Bank Cash Balance stands at just over \$40,397. Our Projected Running Cash Balance is \$35,869 compared to \$23,525 on 5/31/2024.

These are the significant items since our last meeting:

Besides the exceptionally good turnout other main factors for the high net results for the Golf Outing and relative kudos are:

1. \$1,500 Outing Sponsorship. - John Knoebel & Robert Aprati.

2. \$605 from the Self-Funding Golf Contests. This was enhanced by one of the winners donating his \$120 winnings and another giving back \$50. - Andy Youpel

3. Excellent first year Raffle results producing \$405.- Rich & Sharon Williams. This combined with the Silent Auction (\$410) nearly equaled last year's Silent Auction Results of \$885.

4. Golf 4Some Photos were a big hit and garnered \$485. - Bill Johnson, Rich Zarr, Tim Zimbauer and the Lovely Sisters.

Other Benefits came from lowering other Operating Cost i.e., Logo Golf Balls vs Tote Bags.

Sponsorships were on PAR with LY, and we produced several new signs.

The Golf Donations were lower as the prior year included \$1,000 of Golf Fees donated as part of the initial rain out date. Also, remember we refunded \$2,900 in Golf Fees a year ago and rolled over 6 Golf fees into 2024.

These Outstanding results were achieved from a ton of hard work and persistent effort; not just on the day of the Outing but also in the months leading up to 7/10/2024 and the days following.

Not shown in the results below are \$455 of Donation Gift receipts secured at the Golf Outing.

* We paid the 2nd D&O insurance installment of \$260.

* We made a \$1,000 disbursement for the Gregor Mendel Science Award program. These funds will be given to 2 incoming St. Rita Seniors (\$500/each) as a credit to their tuition. This is an annual event that was founded when we created the Gregor Mendel Science and Technology Hall at St. Rita in January 2024.

John Mikenis made the motion to accept the Treasurer's Report. John Franklin seconded the motion. The motion carried unanimously.


Coach Joe Magee Induction Into the Chicago Catholic League Hall of Fame

Tom Gavin explained that many years ago Coach Magee refused to accept the Catholic League's offer to induct him into their Hall of Fame while he was alive.
